Training of National Judges in EU Competition Law

CALL FOR APPLICATIONS

SUMMARY

Following the successful organization of the three previous editions, the Robert Schuman Centre for Advanced Studies (RSCAS) at the European University Institute (EUI) welcomes applications from judges of EU Member States to participate in ENTRANCE 2013, a project co-financed by the Directorate General for Competition of the European Commission.

ENTRANCE is a training course addressed to 54 national judges from different countries interested to deepen their knowledge and share experience in EU competition law enforcement. The focus of ENTRANCE 2014 is on common procedural aspects which characterize the enforcement of competition law, and which ensure the compliance with the right of defence and the principle of due process in the national competition law proceedings.

The requirements to apply are:

1. Having the nationality of one Member State of the European Union;
2. Working as a judge in a national court of one EU Member State in the area of civil or administrative law;
3. Good knowledge of English language;

Participation to ENTRANCE 2014 is free of charge. Tuition fees, travel and accommodation costs in Florence for the selected participants will be covered by the project.

 - iii. The role of the European Convention of Human Rights (ECHR) in competition law enforcement (i.e. right of defense, right of private domicile, principle of *ne bis in idem*)

- **Online activities through a user friendly platform (February - November 2014)**: Participants will use the platform to compare the national cases of application of the competition law through a guided online forum of discussion and analysis of cases study.
